

Project Gram Swaraj Sangh (GSS)

Location - Kutch, Gujarat



The project will continue to be located in Wagad region of Kutch, which has been the main intervention area for GSS.

During the year 2012, the GSS team worked with total of 4 clusters (Fategarh, Gagoghar, Rapar and Balasar clusters) covering 145 wands (hamlets)* and 4118 households and 11242 children.

*Wands/ Hamlets – Are communities located on the outskirts of villages and hence do not have access to any government infrastructure

Situation Analysis

Wagad (stands for wind and rocky land) comprises of Rapar and Bhachao Taluka. The area as the other part of Kutch is disaster prone area due to drought, cyclone and earthquake. These natural calamities are not only damaging the natural resources but also affecting the very economy of the region. The area receives scanty rainfall. The area is one of the most backward and under developed in the state of Gujarat in the western central India.

Most of the people are unskilled labourers and daily wage earners. They also migrate for seasonal farming jobs and livelihood options. 90% of families take their children along when they migrate.

OBJECTIVES FOR January 2012 to December 2012

- To work towards enabling communities to promote and implement Right to Education Act, 2009 in Waghad Area of Rapar.
- Establishment of leadership among most marginalized communities in Waghad area to raise voice against injustice and violation of human rights and child rights.
- Advocate on aspect of Child Labour in Adesar and Rapar taluka as part of Anti Child Labour Campaign.
- Strengthen children groups through various techniques of child participation.
- Carry out awareness building about all schemes related to food security in all 145 wands.

Project Impact during 2012

Right to Survival

Reasons for low immunization

Community resides in hamlets which are far away from main village and therefore they cannot get access to services. There is Inadequate staff in health centre, the community is superstitious and therefore does not give importance to immunization. Seasonal migration of in search of livelihood is one of the key reasons for not being able to immunise all the children.

GSS team has ensured immunization of 313 pregnant women out of 404.

Malnourishment -

During the entire year 140 children (67 girls and 73 boys)were identified malnourished. GSS staff has spread awareness about this amongst the community and also registered these children with the ICDS centre and health department to ensure these children get proper nutrition and recover.

- Children are found malnourished owing to lack of assured food security available to these families.
- ICDS centers don't provide their services regularly and monitor growth of children.
- Poverty leads family members to engage most of the time in labour and hence cannot pay attention to eating habits of children

Birth Registration -

GSS team ensured that (63)20% children received their birth certificate and (226)74% births were registered. Parents are still not fully aware of the importance of birth registration or the process followed for the same

Mid-day Meals (MDM)-

11 schools offered MDM according to Menu, regularised it in 10 schools, and MDM in 72 schools were sustained.

Right to Development

Access to School -

Follow up efforts are carried out for get 22 schools sanctioned. There were 4 new schools sanctioned during the year.

Enrolling children who are out of school -

Out of a total of 545 (231 Girls and 314 Boys) surveyed, 496 (217 Girls and 279 Boys) got enrolled in school. 91% achievement.

Regularising children in school -

Out of the total school going children 4542 (2025 Girls and 2517 Boys); 3657 children (1603 Girls and 2054 Boys) continued to remain in school. Percentage achievement is 80.51% (last year was 77%)

Infrastructure

Water -

Demand for water is now a community led campaign.12 out of 53 hamlets received water connection

Electricity-

Out of 145 wands, 121 wands have electricity connection. 16 of the 30 hamlets received electricity in 2012

School Facility -

Boundary wall was built in 11 schools to ensure security, kitchen facilities set up in 18 schools for cooking of midday meal and sanitation facility provided in 17 schools.

Right to Participation

Children's Groups -

134 children's groups were strengthened and 9 new groups were formed. The total number of membership is now 1027 (469 girls and 558 Boys).

15 new women joined the Women's Group, now the group size is 60. These women are trained and empowered to demand their rights like child rights, right to water and electricity and also resolving of various other issues.

Children from these groups had participated in animation film workshop organized by CRY and made a film on their expressions and aspirations.

Bal Jagat (Children's World) is a magazine published with contribution of articles, poetry, sketches etc from children. It is an expression of their problems and aspirations

Project Jago

Location - Jharkhand



Marked above – district in Jharkhand where Project Jago works in 51 villages

During the year 2012-13, the Jago team worked across two districts (Giridih and Koderma) covering 51 villages and 11,044 children.

Situation Analysis

The District had been famous for Coal and Mica Mines and has several large coal fields, which has been one of key reasons for community displacement. Since last decade after the closure of the mica and coal mines the economy has fallen and community has been converted into daily wage workers. The families are getting involved in the illegal manual extraction of coal and selling it to the middle man or in the open market. This illegal and risky business very often threatens people's lives. Herewith, children are the most vulnerable section of the community as they are engaged in the coal extraction process to supplement the family income rather than attending school. Child marriage and trafficking is also rampant.

Objectives of the Project

- To address issues like child marriage, child labor, dowry death etc.
- To campaign for immunization, malnutrition, birth registration and to address these issues.
- To ensure education for children (enrollment & retention).
- To create space for children in decision making.
